#### Eligibility Criteria

- 1- The estimate cost is a rough guideline of estimate and the actual may vary depending upon the actual execution of work.
- 2-The quoted rate should be clearly mention at the time of submission of the tender
- 3- The tenders shall be in two parts viz. Technical bid and financial bids. Technical bid shall comprise of eligibility documents, IT, ST clearance certificates, esic,company profile and any other document in support of technical capability. The Technical bid should not contain any financial indication. Financial bid shall comprise of Quoted price only with respect to the Bill of Quantities provided with the tender document.
- 4-The contractors will be selected on the basis of the credential and eligibility conditions provided in the technical part. Price bids of the successful bidders in the Technical part will only be opened. The minimum eligibility criteria shall be as follows
  - (a) The intending bidder should have executed similar nature of work for reputed organization with experience of having completed similar during last five years ending last day of month, previous to the one in which Tenders are invited in the following manner :
    - i) One similar nature of completed work costing not less than the amount equal to 80% of the estimated work.
    - (b) Average Annual Turnover is Rs. 5,00,0000/- (Rupees five crore only) in each for last three years
  - 5- The bidder should have completed at least one work of similar type and nature.
  - 6- MGM reserve rights to reject any or all bids without assigning any reason.

- \* " Similar nature of work " means RCC work.
- \* -"Completed work " means - the executed / completed portion of work order,even if the work has not been completed in totality(subject to furnishing the proof of executed item and value of work in the form of certified copy of RA bills )
